#### New project possibilities

# Key Action3 - Social Inclusion through education, training and youth

DEADLINE: May 30 2016, 12:00 CET/CEST (Midday, Brussels time)

#### General Objective:

- 2 General Objectives:
- 1)Preventing radicalization and promoting democratic values, fundamental rights, intercultural understanding, active citizenship;
- 2)Fostering inclusion of disadvantaged learners
- 2 LOTS, 3 STRANDS (UNDER LOT 2)

**Lot1**: Education and Training (formal education)

**Lot2** <u>Youth</u>: youth work, non-formal education:

- -Strand 1 Transnational Coop projects
- -Strand 2 large Scale Volunteering Projects
- -Strand 3 Networking National Agencies

#### Specific Objectives:

You have to choose at least 3

- Improving acquisition of social and civic competences, fostering understanding and ownership of democratic values;
- 2. Preventing/combating discrimination/segregation in education;
- 3. Promoting gender equality in the learning environment;
- 4. Enhancing access to quality and inclusive mainstream education and training;
- Fostering mutual understanding and respect among people with different ethnic or religious backgrounds;
- 6. Enhancing critical thinking, cyber and media literacy;



- 7. Creating inclusive and democratic learning environments;
- 8. Supporting teachers and educators in handling conflicts and dealing with diversity;
- Preventing radicalization in prison and closed institutions;
- 10. Encouraging youth participation in social and civic life;
- 11. Facilitating the acquisition of the language(s) for newly arrived migrants;
- 12. Assessing knowledge and validating prior learning of newly arrived migrants;
- 13. Better non-formal learning activities, youth work practices, volunteering.

#### Budget

Up to **EUR 500,000**. The maximum rate of co-financing is 90% of eligible costs.

#### Eligibility

#### Nationality:

- 1. the 28 Member States of the EU,
- the EFTA/EEA countries: Iceland and Norway,
- EU candidate countries: Turkey, Albania, Serbia, Montenegro and the former Yugoslav Republic of Macedonia.

#### Partnership:

**Strand 1**: 4 organizations representing 4 eligible countries. If networks are involved in the project, the partnership must include at least 2 organizations which are not members

of the network (i.e two partners of the network plus 2 organizations not members of the network)

**Strand 2**: 3 organizations representing 3 eligible countries.

The remaining applicant(s) may come from other relevant sectors and be legally established in any of the eligible countries referred.

Maximum duration of the project: 24 months

# Advocacy: what's up in Brussels?

Last month we mentioned our cooperation with FEANTSA, the European Federation of National Organizations working with the Homeless. We decided to join their action calling for a European Commission Plan to fight homelessness. Many of our members work on this field, thus we are quite motivated to join a common campaign at a European level in this direction. Part of our action will entail asking MEPs to vote positively on a European Parliament written declaration to make this request to the Commission. This will allow us to have a good opportunity to meet many of them, and to recruit more "YMCA friends".

Many things are happening at the moment in the realm of youth policies. PES (the European Socialist Party) has presented on April 22<sup>nd</sup> a PES Youth Plan, pushing mostly on reducing youth unemployment. This is good news in the sense that it is one of the signs of how youth comes at the forefront of



the European Parliament's agenda today. Another important sign of that is the fact that the Youth Intergroup of the European Parliament has organized with the YFJ a consultation of European NGOs on the Multi Annual Financial Framework of the EU (MFF). The MFF sets the priorities for EU spending over the 7 years' period of programming of the EU: if a priority is not inserted in the MFF, it does not get funding. YMCA Europe was among the NGOs consulted on May 3<sup>rd</sup> in Brussels, and we were able to give our priorities to both the Commission and the Parliament. We underlined how **funding** for youth organization needs to be expanded, and more accessibility to this funding is needed, through simplification and expansion of the eligibility of youth NGOs to apply to nontraditional youth programmes (like Horizon 2020 or Cohesion funds). We suggested to mainstream youth into every EU programmes, not limiting funding opportunity to a "youth reservation". This is how YMCA Europe can influence EU programming at its source.

We also met the Rapporteur of the Erasmus+ implementation report with the YFJ Funding Network: we were able to suggest what needs to be modified, reviewed or kept.

Many other interesting events happened in Brussels in April. Among them, there was the Conference at the European Parliament on 26 April on "European Muslims: radicalization and de-radicalization". This was an illuminating insight into the causes of radicalization, and to the plight of young Muslims struggling to integrate and to find a solid identity. The many attendants stressed the importance of services and support for youth and families, giving opportunities, hope and a space to dialogue.

### YFJ and the Council of Members (COMEM)

The European Youth Forum (YFJ) met on April 15 and 16 in Brussels to reunite its Council of Members. In this occasion, the members voted on 4 Resolutions drafted initially by the YFG, and shape in this way the political position of the YFG on several issues, something very important to define the collective advocacy of all European Youth Organizations towards the European Institutions.

YMCA Europe presented **7 amendments** to the YFJ Policy Papers, thanks especially to our Representative **Heidi Silvén**, in cooperation with the Brussels office and the YPG. We presented 3 amendments to

the Quality Standards for Youth Policy Paper, 2 on Youth Autonomy and Inclusion, and 2 on Equality and Non-Discrimination. We managed to have 4 of these 7 amendments passing the vote of the Council of Members: the amendments focused on the importance of the role of youth organizations and their recognition by key institutions and governments in particular.



We cooperated successfully with other Value-Based Organizations, focusing on common goals and building efficient positions to influence the policy papers of the YFJ. These papers are focused on important values and positions, and it is important that YMVCA Europe makes sure that these documents reflect our identity and beliefs as well, as much as possible. The **next step** will be the next COMEM in November, where the new YFJ Board will be voted upon, and the YFJ Operational Plan as well. YMCA Europe will work to ensure the Plan follows our New Strategy. Soon we will start a process of consultation on that: please contact us if you want to give some insight or opinion!
