##### **7.6.1 Report 2007**

Ed Eggink, Treasurer, gave the report and guided the General Assembly through the financial documents included in the Assembly Working Documents.

The Training Centre is a separate operation from 2007 and onward, so it is no longer part of our financial reporting. As the YMCA Europe Festival is running as a separate legal entity, it is also no shown in the report.

He expressed thanks for the good support from the National Movements and that the national contributions are paid in time.

The currency fluctuation is still causing losses, but measures are taken to minimise it.

The accounts resulted with a surplus of 631 Euros.

*Decision:* The Financial Accounts for the year 2007 were unanimously approved.

#### 7.6.2 Auditors' Report and Discharge of Executive Committee

The Auditors' Report was explained by Peter Posner.

Denmark raised a question about the transparency on the system of the national contributions, and asked that the issue must be raised for discussion after the YMCA Europe Festival. Peter Posner explained about the process and the difficulties in the World Alliance concerning the Fair Share system.

*Decision:* The proposed budget and the National Contributions 2009 were approved with one abstention.

*Decision:* The Operational Plans 2008/2009 as formulated by the Executive Committee were unanimously received.
